	for the 2026 breeding season beginning February 2 <sup>nd</sup> , 2026 & ending, June 29 <sup>th</sup> , 2026. The mare owner agrees to pay
a breeding	fee of \$2000 which includes a \$500 non-refundable booking fee. This contract is not valid until the booking fee is paid, if
check is no	et submitted with contract, we will charge the card provided. Any deviation from these terms must be specified in writing and
signed by F	Red River Equine LLC. All payments must be made payable to Red River Equine, LLC.

PRE-BREED	DING ARRANGEMENTS: The mare owner must provide the following information to Red River Equine LLC when booking a mare:
1.	Copy of both sides of registration papers. If breeding a thoroughbred mare an AQHA "T" number is mandatory for registration.
	This is a requirement, not a suggestion.
2.	Completed Information Sheet (page #4)

- 3. Signed breeding contract
- 4. All Applicable fees:
  - a. The booking fee & breed fee must be paid in full before any cooled/frozen semen will be shipped.
  - b. Any incomplete registration certification or unpaid charges will result in a hold of the mare's name on the appropriate stallion breeding report costing you additional money.
  - c. Semen will not be shipped to any mare unless a current credit card number and expiration date is on file with Red River Equine LLC or shipping is prepaid with a check or money order payable to Red River Equine LLC.

## **BREEDING ARRANGEMENTS:**

- 1. Collection days are Monday/Wednesday/Friday. It is the mare owner's and his/her veterinarian's responsibility to confirm our breeding/shipping days.
  - Cooled semen is on a FIRST CALL first serve basis, please make sure to call early to be put on the list. If cooled semen is not available frozen semen will be offered at the stallion manager's discretion.
  - Frozen semen will be released one dose (8 straws) per cycle (Initial Here)
- 2. To guarantee shipping, mare owner or agent must give at least 24-hour notice of possible semen shipment required to Red

River Equine LLC and confirm shipment prior to actual shipment by 8 AM CST on day of collection. No guarantee will be made that cooled semen will be available. It is first call, first serve.

- 3. Every effort will be made to accommodate your mare's breeding time frame; however, it is the mare owner's responsibility to keep in touch with Red River Equine so that your veterinarian and ours can get your mare in foal in a timely manner. Failure to adhere to these arrangements may result in missed heats and delayed shipments, at the mare owner's expense. A veterinarian knowledgeable in successful insemination techniques (including deep horn) must oversee off-site inseminations to maximize the potential of a timely pregnancy.
- 4. If a mare dies or is deemed unfit to breed during the breeding season, a substitute mare (approved by Red River Equine LLC) may be bred without any additional breeding fee. No refunds given on any fees associated with this contract.
  - ALL MARE CHANGES + SHIPPING CHANGES MUST BE SUBMITTED IN WRITING IN EMAIL AT LEAST 24 HOURS PRIOR
     TO SHIPMENT OR WE CANNOT GUARANTEE SHIPMENT. (Initial Here)
- 5. The mare owner agrees to have the mare checked by ultrasound no later than 18 days after insemination. If ultrasound is unavailable, mare owner agrees to have the mare checked for pregnancy with heartbeat by licensed veterinarian within 30 days of insemination. Mare owner agrees to provide Red River Equine LLC with the results of the pregnancy exam no later than 30 days after insemination with last breeding date.
- 6. <u>Limited live foal guarantee:</u> A live foal is defined as one that will stand and nurse. If foal is born dead, mare owner agrees to furnish the stallion owner, within 7 days, a certification that the foaling was an attended foaling and deliver a written statement from a licensed veterinarian giving details required to substantiate the failure of the mare to produce a live foal. The mare owner will have the same right to substitute a different mare for the rebreeding provided that the substitute mare has been approved by Red River Equine LLC. In such a case, return privileges will be available for one additional season only following original contract season. Rebreeds must pay the rebreed chute fee and any shipping charges applicable.
  - If the mare owners fail to rebreed the mare the following year after original contract, then any and all fees
    become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of
    this contract, unless otherwise agreed in writing and signed by both parties. (Initial Here)
- 7. We do not offer color guarantee.
- 8. Embryo transfers if more than one embryo is produced, an additional stud fee will be due at 30 days pregnant of each additional embryo.

## SHIPMENT INFORMATION & ADDITIONAL CHARGES FOR COOLED TRANSPORTED SEMEN:

It is the mare owner's responsibility to order a shipment at least 24 hours in advance.

- 1. Semen that is picked up from Red River Equine LLC by mare owner or agent will have a packaging cost of \$150 charged.
- 2. Cooled Semen will be sent via FedEx/UPS (next day arrival) at a rate of \$350.
- 3. Frozen semen will be sent via FedEx/UPS (next day arrival) at a rate of \$600.
- 4. Counter to counter airline shipments (same day arrival) are available at a rate of \$450 per shipment. Availability of airline shipment depends on air cargo routes operated by airlines contracted with Red River Equine LLC.
- Canadian Shipments will be sent Via Fedex/UPS (next day arrival) at a rate of \$650. All Canadian USDA shipments include a USDA Health Certificate, Commercial invoices and shipping cost.
- 6. If FedEx/UPS delivery is not available within a 24-hour period, additional notice will be required. Mare owner should check with FedEx/UPS for Saturday Delivery, holiday delivery or customer pickup and provide another acceptable delivery address.
